Explanatory Notes:

1. **This Certificate of Identity form can only be used for the purpose of providing supporting documentation as part of an application for a Consular ID and should not be used for any other purpose.**
2. **This Certificate of Identity form should only be used in the following circumstances:**
 - a. You do not have any form of valid photo ID to submit with your application, because either:
 - i. you are a first-time applicant
 - ii. or because, having previously held a Belize issued ID, it has been: lost, stolen or destroyed and declared as such.
3. **This form should be signed in the presence of a Notary Public, and witnessed by a parent of the applicant.**
4. **The witness must complete section 2 of the form in full.**
5. **The witness must present a valid photo ID.**
6. **The notary must certify where shown on the form: "I CERTIFY THIS TO BE A TRUE LIKENESS OF THE BELOW SIGNATORY", and sign.**
7. **The notary's seal/stamp must be affixed on the back of the photo half on photo and half on form. (please do not obstruct the face with a staple when attaching the photograph).**
