Proof of US address in the form of utility bill or lease/rent contract (if <b>no utility bill or lease agreement for residence the person whose name is on utility bill or lease must provide a notarized declaration confirming that the applicant resides at address</b>)</li> <li>5. Notarized "Certificate of Identity Form" (<b>when requirements at no. 3 cannot be met</b>)</li> <li>6. If applicant has a valid, unrestricted passport, applicant need only present said passport.</li> <li>7. <b>Minors:</b> (under 16 years) In addition to the above requirements: (I) Minors must be accompanied by their parent (II) Parent will need to present a valid photo ID</li> <li>8. <b>Married Women:</b> (I) Original marriage certificate/license; (ii) Original Divorce Degree (if applicable)</li> </ol>
